All participants (rider, owner, trainer) must sign the NJPB&O, Inc. release form. Entry and release forms available at www.njponybreeders.org. *One form per pony/rider combination, please.* Show will be limited to 55 rides, so enter early.

AWARDS: Six ribbons per class. Horsemen's Outlet Perpetual Trophy for best average of two or more scores of same pony.

START TIMES: Please include your *legible* email address on entry form to receive start time. If no access to email, call secretary between 7 and 9 PM on Thursday, Sept.9., 2010.

DIRECTIONS: Rt. 31 to Stanton Station Rd. At end, turn right onto Old Clinton Rd. and watch for sign for Millbrook Farm on the right. From rt. 78, follow rt. 31 south; from rt. 202, 1, 206, or 295/95 follow rt. 31 north. Millbrook Farm is located just to the west of rt. 31.

OTHER INFORMATION: No food available. **NO DOGS.** No un-entered horses allowed on grounds. ASTM helmets must be worn by juniors when mounted. Management reserves the right to cancel, combine, or change classes or judge.

RULES

Every entry at a New Jersey Pony Breeders & Owners, Inc. competition shall constitute an agreement and affirmation that all participants, which include without limitation the owner, lessee, trainer, manager, agent, coach, driver, rider, handler, trainer and the pony, for themselves, their principles, representatives, employees and agents:

1. shall be subject to the Constitution and Rules of the Association and the local rules of the competition;
2. represent that every pony, rider, driver, and handler is eligible as entered;
3. agree to be bound by the rules of the New Jersey Pony Breeders & Owners, Inc. pony-show competition, and will accept as final the decision of the management on any question arising under said rules, and agree to hold New Jersey Pony Breeders & Owners Inc., their officials, directors and employees harmless for any action taken.
4. agree that as a condition of and in consideration of acceptance of entry they authorize New Jersey Pony Breeders & Owners, Inc and/or the competition management to market, transfer, assign or otherwise make use of any photographs, likenesses, films, broadcasts, cablecasts, audiotapes, or videotapes taken of the pony(ies) and participant(s) while on the grounds, incident to, or in transit between, the stabling facility, and the event site in any way they see fit for the promotion, coverage, or benefit off the event or sport, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service, and hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to invasion of privacy, right of publicity, or to misappropriation;
5. and agree that they participate voluntarily in the competition fully aware that equine sports and the competition involve inherent dangerous risk or serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold New Jersey Pony Breeders & Owners Inc. and their officials, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during or in connection with the competition whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of New Jersey Pony Breeders & Owners Inc.
