## **GENERAL RULES & INFORMATION**

**Entry Sheets:** One pony/cob per entry sheet. Multiple hitches must be entered with one hitch per entry sheet. Additional entry sheets will be available.

**Sanction Fee:** \$3.00 per pony/per judge for each show.

**Rules:** Entries are made with the understanding that exhibitors are familiar with the rules of the Welsh Pony & Cob Society of America and the Welsh Rules of the USEF. Every class offered will be governed by those rules. A signed entry sheet serves as an understanding of these rules.

**Vehicles:** No wire wheeled or pneumatic tire vehicles are permitted in any class except roadster.

**Papers:** All Welsh classes are open to Welsh Ponies/Cobs/Half-Welsh registered with the Welsh Pony & Cob Society of America. Registration papers must be current and copies of the registration papers must accompany each entry. Lease papers must be presented if exhibiting another owner's pony/cob under your own name with a copy of the registration papers listing the lessee. These requirements will be strictly enforced.

**Measurements:** All ponies age six (6) and over must have either a permanent measurement card issued by USEF or WPCSA, copies of temporary measurement forms received at 2 WPCSA sanctioned shows during a 2 year period, or a current year USEF temporary measurement form. All exhibitors who are not members of the WPCSA must pay a \$5 fee per measurement. Measurement required on all performance ponies/cob.

**Measurement times are:** 7:00-8:00 AM.

**Refunds:** Stabling fees & sanctioning fees less an office fee are refundable with a vet certificate. Entry fees are non-refundable.

**Camping:** Camper hook ups are available at \$30.00 for the event. A dump station is available at the back of the fairgrounds. **Camper Permit Sign** must be displayed by door of camper or in front window at all times.

**Coggins Test:** Certificate or copy thereof, must be attached for each pony/cob (except for foals) and must be current within one year of the show for all out of state ponies.

**Stabling/Shavings:** Stalls + 2 shavings are available for \$50.00 each, which includes cleaning (**no refunds**). Additional bedding will be available at the fairgrounds. Please indicate the number of stalls required including tack stalls on your entry form. Stalls are box stalls with half doors. **Late or early arrivals:** Check at Stall Managers Trailer for stall assignments.

**All stalls must be vacated no later than Monday at 06:00 AM.**

**Stall:** All owners are reminded that if you require a **Stall Guard** on the front of the stall above the door, you must provide your own. If you require additional locks you must provide them.

**Dogs:** All dogs must be kept on a leash at all times. This is a Fairgrounds rule.

**Ring Rules:** While the class is being judged, no person is permitted in the ring except the judge, ring steward and if needed, show officials which the judge has requested. The judge has the authority to excuse any pony/cob that he/she feels is unsafe or unruly or any exhibitor he/she feels is exhibiting in a dangerous manner. No Judge, exhibitor, handler, rider, or driver may use a cell phone while in the ring.

**Junior Exhibitor:** A junior exhibitor is one who has not received his/her 18<sup>th</sup> birthday as of December 1<sup>st</sup> of the current competition year. The age of an individual on December 1<sup>st</sup> will be retained throughout the competition year.

**Class Calls:** To keep the show moving along as smoothly as possible, exhibitors must be ready at the gate when their class is called. If you require a tack and/or pony/cob change, INDICATE THIS ON YOUR ENTRY SHEET. If you find you need a tack change once you get to the show, please advise the show office AS SOON AS POSSIBLE.

**Helmets:** Helmets are strongly recommended while riding around the grounds. All juniors are required to wear approved safety helmets (ASTM/SEI) while mounted or riding in a pony/cob driven vehicle.

**Futurity Ponies:** Futurity Ponies must submit an Entry Form, (For office use).

**Food Service:** Food will be available on the grounds and will be available with breakfast and lunch menus.

**Attire:** In all classes, exhibitors must be appropriately and safely dressed in conservative attire. Those persons, who in the opinion of the judges, are inappropriately attired, may be penalized.

**Safety:**

**Removing the bridle from an animal harnessed to a vehicle, or leaving an animal unattended while hitched, anywhere on the grounds, will result in instant elimination and removal from the show grounds.**

Junior exhibitors must wear approved protective headgear (ASTM/SEI) at all times whenever mounted or in a driven vehicle while on the show ground. Harness must be secured and properly fitted. Any rider violating this rule at any time will be immediately prohibited from further riding until such headgear is properly in place.

The Ohio Welsh Pony Association, Welsh Pony & Cob Society of America, and Mahoning County Fairgrounds will **NOT** be responsible for any accidents, thefts, or losses that occur at the show or on the fairgrounds. A signed entry sheet serves as an understanding of this release.

**CHAMPIONSHIPS:** Division Championship points or ribbons will not be awarded unless the division qualifies with a minimum of three (3) entries in each class of the division.

**ENTRY FEES: PRE-ENTRIES CLOSE JULY 21, 2010.**

Post entries will be accepted up until two (2) classes prior to class being entered. The Welsh Pony & Cob Society of America Recording Fee is \$3.00 per judge per pony/cob per show.

**PREMIUMS:** Premium checks will be mailed after the close of the show. When prize money is offered in a class, it will be paid if three or more entries are shown and judged.

Futurity Classes:	Per futurity Rules. Ribbons & 5 places.
Halter and Youth Classes:	Ribbons & 4 places **
Performance and Performance Stake Classes:	Ribbons to 4 places & Premiums to 4 places; \$16, \$14, \$12, \$10

\* All classes specifically restricted to youth and junior will not receive a payback.

**GENERAL CONDUCT:** Owners/agents/exhibitors will refrain from any act committed or remark made in connection with the competition considered offensive and/or made with intent to influence or cast aspersions on the character or integrity of the judging. Owners /agents/exhibitors may not inspect the judge's card without the judge's permission nor approach the judge without first gaining permission from show management. Owners/agents/exhibitors are expected to behave in a sportsmanlike manner, observing the rules of the sanctioned WPCSA competition and following the rules of the local show management. **The show committee reserves to itself the right of declining to receive any entry, to return any entry fee before or during the show and to remove any horse, pony, groom, or exhibitor from the show without being liable for compensation.**

**DELAY OF CLASS:** When the start of any class requiring ponies/cob to be shown individually is delayed by animals not ready to perform, the competition may be closed at the order of the judge or Show Committee, providing a warning is issued and exhibitors are given three (3) minutes to appear at the in-gate, ready to participate. Exception: Hunter/Jumper classes where a specific jump order is given. In classes where animals are shown collectively, a warning is given and the in-gate must be closed two (2) minutes after the first animal enters the ring.

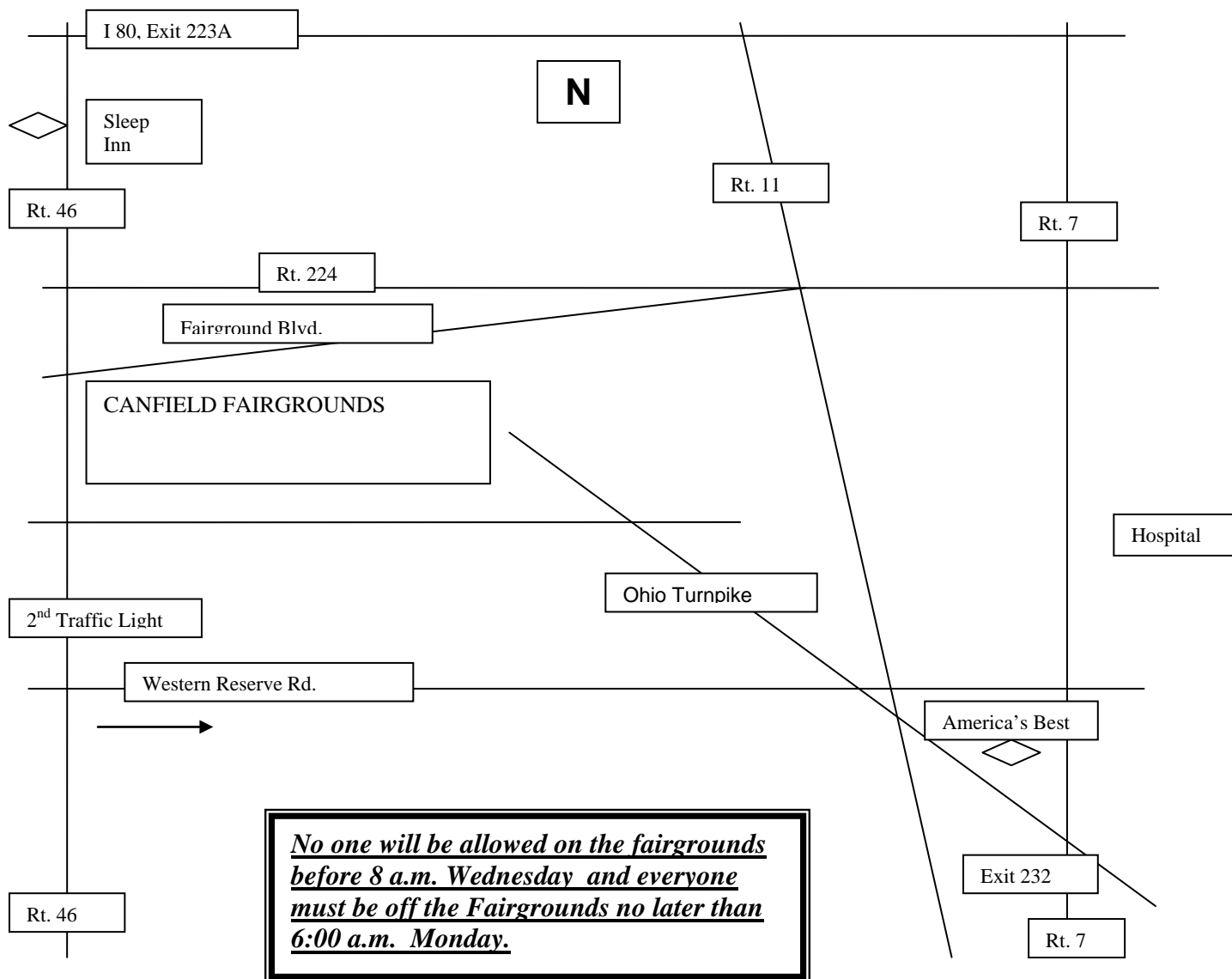

## CLASS DESCRIPTIONS

CLASSES WILL BE SPLIT SHOULD ENTRIES WARRANT, PER THE WPCSA RULES UNLESS OTHERWISE STATED.

**BREED CLASSES (Article 110.2):** Animals are to be shown in hand at a walk and trot except in group classes. Purebred Welsh to be judged 85 % on breed type, conformation, way of going, quality and substance and 15% on disposition and manners. Natural reaching action is desired. Half-Welsh to be judged 85% on conformation, way of going, quality and substance and 15% on Welsh breed type, disposition and manners.

**WPCSA WELSH ENGLISH PLEASURE (Article 112.3):** To be shown at a walk, trot and canter both ways of the ring on light contact without martingale. To be judged 75% on performance, manners, movement and style; 25% on breed type and conformation. Working classes are judged 100% on performance.

**WPCSA WELSH WESTERN PLEASURE (Article 112.4):** To be shown at a walk, jog and lope both ways of the ring without martingale on a reasonably loose rein without undue restraint. To be judged on performance, with emphasis on manners 65%; breed type, movement and conformation 25%; appointments 10%. Working classes are judged 100% on performance.

**WPCSA WELSH HUNTER ( Article 112.5):** Over fences(o/f): To be shown over a course of a minimum of six fences with eight jumping efforts of the required height. To be judged 75% on performance, manners, movement and style; 25% on breed type and conformation. Working classes judged 100% on performance. Animals not exceeding 13.2 hands will jump 2'0", animals exceeding 13.2 hands shall jump 2'6". Under saddle (u/s): To be eligible, pony must have shown in and completed an over fence class. To be shown at the walk, trot and canter both ways of the ring. **May be required to hand gallop one way of the ring, but no more than eight animals at one time.**

**WPCSA SHORT STIRRUP HUNTER (Article 112.6):** Division is open to riders 12 years and under. Classes are open to all ponies/cobs/half-Welsh. **RIDERS** in this division, including the under saddle class may not compete over fences in any other division except Short Stirrup Equitation. Courses to be set at 18" with a minimum of 4 fences with 8 jumping efforts required. May either trot or canter the entire course. Over-fence classes must precede the under-saddle class. To be judged 100% on performance. To be eligible for the under-saddle class, pony must be entered **and completed** a course in at least one over-fence class. Under-saddle class animals showed both ways of ring at a walk, trot and canter.

**WPCSA LONG STIRRUP HUNTER (Article 112.7) –Ages 13 to 17 and Adult:** Classes are open to all ponies/cobs Half-Welsh. **RIDERS** in this division, including the under saddle class, may not compete over fences in any other division at that show where the fences exceed 18". Courses to be set at 18" with a minimum of 4 fences and eight jumping efforts required. Over-fence class must precede the under-saddle class. To be judged 100% on performance. May trot or canter the entire course.

**WPCSA LOW HUNTER (Article 112.8):** Division is open to ponies/cobs and half Welsh. These **ANIMALS** may not compete in any other over fences division at that show where fence heights exceed 18". There are no restrictions on the rider. Courses to be set at 18" with a minimum of 4 fences with 8 jumping efforts required. Over-fence classes must precede the under-saddle classes. To be judged 100% on performance. May either trot or canter the entire course. This division is open to juniors and adults.

**WPCSA WELSH PLEASURE DRIVING (Article 113.1):** To be shown to a suitable two or four-wheeled vehicle or four-wheeled vehicle for pairs, but not a viceroy, racing sulky, or Fine Harness rig. To be shown both ways of the ring at a walk, working trot and trot on and stand quietly and except for tandems, to back readily. To be judged 75% on performance, manners, movement and style; 25% on breed type and conformation. Working classes are judged 100% on performance.

**WPCSA CARRIAGE DRIVING (Article 113.2) (wire wheeled vehicles can be used if stated in prize list.)** Classes open to ponies/cobs/half-Welsh. In addition to the gaits detailed in the pleasure driving section (Article 113.11) (walk, working trot, trot-on, halt and rein back), carriage driving also requires the slow trot where the animal should maintain forward impulsion while showing submission to the bit. Turnout to be judged 70% on the condition, fit and appropriateness of harness and vehicle, neatness and appropriateness of attire and overall impression; 30% on performance, manners and way of going Working class to be judged 70% on performance, manners and way of going; 20% on condition and fit of harness and vehicle; 10% on neatness of attire. Obstacle/Cones to be judged 100% on performance. Rules for obstacle/cones need to be added to prize list.

### **WPCSA Obstacle - Pick Your Route**

1. To be driven over a course of obstacles (paired markers) with no set route. The number of obstacles to be proportionate to the dimensions of the driving area. Not to exceed 20 obstacles.
2. Typically obstacles in this type of class are not measured for each entry, but are set at 2.5 meters or 8'3" at the start of the competition, and only reset in the event of a knockdown.
3. After passing the starting line, the driver shall proceed through each obstacle to the designated finish line, choosing his own route. Each obstacle is to be negotiated once and only once, but may be approached from either direction.
4. Course faults are scored as penalty seconds and are added to the driver's elapsed time. Placings are determined on a low total time basis. Ties for first will be decided by a drive-off (unless otherwise stated in the prize list).
5. Penalties (as they differ from those under penalties section):
  - a) Knocking down or dislodging obstacle 5 seconds
  - b) Driving through an obstacle again 10 seconds each time
  - c) Missing an obstacle Elimination

**WPCSA LEADING REIN (Article 115.1):** Section A, B, C or Half-Welsh, mare or gelding, 12.2 hands and under, to be ridden by junior exhibitors at least four, but not more than eight, years of age. Riders to be suitably dressed in Hunt, Saddle or Western attire including protective headgear. To be shown at a walk, on the right rein (clockwise), to line up and stand quietly. Ponies will be called out individually to stand, walk out and trot or jog back past the judge. **Ponies to be judged** on manners, suitability, breed type, conformation and turn-out. This is not an equitation class. **There are no restrictions for the pony or rider.**

**WPCSA CHILD'S FIRST PONY (Article 115.2):** Section A, B, C and half-Welsh, mare or gelding 12.2 hands and under, to be ridden by junior exhibitors at least four, but no more than 10, years of age. Riders to be suitably dressed in Hunt, Saddle or Western attire including protective headgear. Ponies to be shown at a walk and trot or jog, both ways of the ring. **Ponies to be judged** on performance, manners and suitability. Conformation, way of going, and turnout to be emphasized. This is not an equitation class. **There are no restrictions for the pony or rider.**

**WPCSA TRAIL (Article 115.3):** English or Western equipment. Open to all ponies/cobs/half-Welsh. To be shown over and through obstacles at a walk, optional trot or jog and optional canter or lope. To be judged 100% on performance. Juniors not to side pass or lope/canter over loose rails.

**WPCSA LEADLINE WALK (Article 115.4):** Classes open to riders 7 & under mounted on ponies/cobs/half-welsh. Judged on equitation and suitability of mount at a walk. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk-trot, and leadline walk-trot poles.

**WPCSA LEADLINE WALK-TROT (Article 115.4):** Classes open to riders 7 & under mounted on ponies/cobs/half-Welsh. Judged on equitation and suitability of mount at a walk and trot/jog. To stand quietly. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume and leading rein, leadline walk and leadline walk-trot poles.

**WPCSA LEADLINE WALK-TROT POLES (Article 115.4):** Classes open to riders 7 & under mounted on ponies/cobs/half-Welsh. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or entirely at a trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. May be ridden at either a walk or trot/jog. To be led by an adult or a junior age 12 or over. Both handler and rider to be appropriately attired. English or Western attire is acceptable. No chain leadlines. **RIDERS** ineligible for other ridden classes except costume, leading rein, leadline walk and leadline walk-trot.

**WPCSA WALK (Article 115.5):** Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh. Judged on equitation and suitability of mount. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk-trot and walk-trot poles. To walk both ways of the ring.

**WPCSA WALK-TROT (Article 115.5):** Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh. Judged on equitation and suitability of mount. To walk and trot/jog both ways of the ring. Possible test to include: walk, trot/jog, turn, halt and rein back at spots marked. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot poles.

**WPCSA WALK-TROT POLES (Article 115.5):** Classes open to riders 11 & under mounted on ponies/cobs/half-Welsh. Judged on equitation and suitability of mount. To be ridden once around a course of four poles on the ground entirely at a walk or trot/jog. Poles are to be placed at a minimum of 4 feet off the rail, two on each side of the ring, simulating a hunter course. The poles should be placed far enough away from the entrance gate to provide an adequate sized area to do an opening and closing circle. May be ridden at either a walk or trot/jog. English or Western attire is acceptable. **RIDERS** ineligible for other ridden classes except costume, leading rein, child's first pony, walk and walk-trot.

**WPCSA SHOWMANSHIP (Article 115.6):** Classes should be offered for exhibitors 12 & under and 13-17 years of age. Judged on presentation and showman's ability to show his/her pony/cob/half-Welsh. 40% of the judging is on neatness and appearance of the showman, pony and tack. 60% will be based on the exhibitor's ability to present his/her pony/cob/half-Welsh. Exhibitors will be informed of the judge's choice of pattern to be used before entering the ring.

**WPCSA RIDDEN COB WELSH CLASSIC SEC. C & D (Article 115.7):** This class is for registered Welsh Cobs and Welsh Ponies of Cob Type 4 years of age and over. To be judged 50% on performance and 50% on conformation. Class is an English class only. No Western, Saddle Seat or Side Saddle tack or attire. To be shown at the walk, trot, canter and gallop, on both reins as a group, displaying Welsh movement as described in the breed description. An individual performance showing all four gaits in both directions by each participant will be required (the gallop need only be shown in one direction). Each animal will then be stripped for conformation judging. Once an entry has been judged for conformation it may be retacked. UK Judge or qualified American Judge to officiate.

**WPCSA RIDDEN WELSH CLASSIC SEC. A&B (Article 115.8):** This class is for registered Welsh Ponies, Section A & B, 4 year of age and over. To be judged 50% on performance and 50% on conformation. Class is an English class only. No Western, Saddle Seat or Side Saddle tack or attire. To be shown at the walk, trot, canter and gallop, on both reins as a group, displaying Welsh movement as described in the breed description. An individual performance showing all four gaits in both directions by each participant will be required (the gallop need only be shown in one direction). Each animal will then be stripped for conformation judging. Once an entry has been judged for conformation it may be retacked. UK Judge or qualified American Judge to officiate.

**WPCSA BEST RIDDEN AND RESERVE BEST RIDDEN CHAMPIONSHIP (Article 115.9):** To be judged 50% on conformation and 50% on ridden performance. Open to first and second placed winners from the Ridden Welsh A/B Classic and the Ridden Welsh C/D Classic. There is no entry fee for this class. This is an English class only. No Western, Saddleseat or Side Saddle tack or attire. Places will be awarded for the Best Ridden and the Best Ridden Reserve. Any animal in this class is eligible to be named the Best Ridden. Entries shall enter the arena at a walk in a clockwise direction. The Judge shall request all four gaits (walk, trot, canter, gallop) in at least one direction, but animals need not show in both directions. The judge shall consider the size of the ponies/cobs, ages of riders, safety of arena when determining whether to have the animals perform as a group or individually. Individual pattern is optional at the judge's discretion. Entries shall not be stripped as conformation score from the qualifying class shall be carried forward.
